MEMORANDUM OF UNDERSTANDING AMONG

STOCKTON UNIVERSITY, CAMDEN COUNTY COLLEGE AND CAMDEN'S PROMISE CHARTER SCHOOL

This Memorandum of Understanding ("MOU") is made as of April 30, 2021 (the "Effective Date") by and among Camden's Promise Charter School ("Camden's Promise Charter School"), a public charter school in the City of Camden, New Jersey, Stockton University ("Stockton"), a New Jersey public institution of higher education, and Camden County College ("Camden County College"), a New Jersey public institution of higher education.

Purpose

WHEREAS, Camden's Promise Charter School and operates a high school known as Camden Academy Charter High School ("Camden Academy High School"). Camden Academy is committed to providing quality education that fosters academic, social, and community development, through a focus on four pillars: Scholarship, Character, Leadership, and Service - leading to lifelong learning and enlightened citizenship; and

WHEREAS, Stockton is dedicated to providing students with the knowledge and experience to tackle the most important issues of our time; and

WHEREAS, Camden County College strives to actively provide quality postsecondary education that leads to gainful employment for residents of Camden County and the surrounding community; and

WHEREAS, all institutions strive to offer educational opportunities that provide intellectual and personal growth.

NOW THEREFORE, in consideration of the foregoing and the agreements below, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Camden's Promise Charter School, Stockton and Camden County College agree to enter into this Memorandum of Understanding so that all institutions can continue to advance their shared institutional mission.

Guaranteed Admission

In recognition of Camden Academy's academically rigorous college preparatory curriculum that exceeds the minimum core requirements of a high school education and earns high college placement of its graduates, Stockton, Camden County College and Camden Academy hereby enter into this MOU to facilitate the seamless enrollment of Camden Academy students into Stockton upon earning their high school diploma.

Under this agreement, Camden Academy students will be guaranteed admission into Stockton as a full-time matriculated student under the following conditions:

- graduate from Camden Academy with an earned high school diploma;
- earn a minimum GPA of 3.0 or better (students with GPAs below 3.0 will be reviewed on an individual basis); and
- satisfy all other admissions application requirements.

Or

• Students will successfully complete the Camden County College, College Now Program earning an Associate of Arts degree by the end of their senior year of high school

Or

• If a student does not meet the above minimum admissions requirements, the student will be conditionally accepted to Stockton and encouraged to initially matriculate at Camden County College Transfer Pathways partnership.

In accordance with the terms and condition of this MOU, Stockton will:

- waive the undergraduate admission application fee;
- provide on-site personal admissions advisement at the Charter Academy for prospective students and parents;
- provide on-site general college search and financial aid workshops and presentations at the Charter Academy; and
- award competitive academic and partnership scholarships to qualified Camden Academy students.

In accordance with the terms and condition of this MOU, Camden Academy will:

- publicize the agreement to students and parents;
- provide regular arrangements for Stockton admissions and financial aid counselors to visit Camden Academy and meet with Camden Academy students; and
- develop a mutually agreed-upon process for mailing information about the Memorandum of Understanding to juniors with the costs to be incurred by Stockton.

In accordance with the terms and condition of this MOU, Camden County College will:

- Assist Camden Academy in planning, marketing and delivery of student testing and assessment.
- Provide Camden Academy with a program orientation for the College Now Program and assist with periodic advisement and registration.
- Provide planning, scheduling, marketing and delivery of courses agreed upon by Camden County College and Camden Academy.
- Provide Camden Academy with the same services that are offered to all Camden County College students.
- Provide academic transcripts to Camden Academy students upon completion of courses offered.
- Provide on-going communication with Camden Academy staff to facilitate the requirements of the courses and compliance with Camden Academy initiatives.

• Provide Camden Academy with a universal release form to distribute to their students for signatures that will authorize Camden County College to provide Camden Academy with student grade reports.

Partnership Scholarships

Stockton will provide institutional academic and merit scholarships to qualified Camden Academy graduates. These scholarships are renewable for four years, provided the student remains a full-time student and maintains at lease a Stockton Grade Point Average (GPA) of 3.0 as defined by the Stockton. When a scholarship is awarded, Stockton will inform the student of the GPA requirements to ensure renewal of the scholarship. In accordance with the terms and condition of this MOU, Stockton will award a combination of academic and merit scholarships for the (2021-2022) academic year. Students are not required to submit SAT or ACT scores as part of the scholarship review process. Stockton will be utilizing both academic and extracurricular achievement to determine scholarship eligibility.

Academic:

• Official High School Transcript

Extracurricular:

- Work (part-time or summer jobs)
- Volunteerism or Community Engagement
- Family responsibilities
- School/Community clubs/organizations
- Arts/Music/Sports
- Other experiences that have been meaningful to the student

For scholarship consideration, students must complete the activity section within the Common Application or submit the Stockton University Scholarship Activity Survey. Students may enter up to ten (10) activities to be considered for scholarship consideration.

Dual Credit College Courses

Stockton agrees to accept college credits earned by Camden Academy students enrolled in the Camden County College high school's dual credit programs, provided that:

- the course(s) are taught by colleges and universities that are regionally accredited by organizations recognized by the Council for Higher Education Accreditation;
- the course(s) are recorded on the regionally accredited college or university's official academic transcript;
- the student earns a grade of C or better; and
- the student enrolls at Stockton as a degree-seeking matriculated student.

Additional Opportunities for Collaboration

Additionally, Camden's Promise Charter School, Camden County College and Stockton will agree to explore other appropriate ways the institutions might collaborate including:

- joint public relations, student recruiting, marketing, and promotion opportunities;
- joint grant-funding opportunities;
- visiting faculty lectures and professional presentation exchanges;
- · student collaboration and peer mentoring;
- facility and other resource sharing opportunities;
- internship and cooperative education opportunities.

Term, Renewal, and Termination

- A. This Memorandum of Understanding shall act as an affiliation agreement among the parties so that the students and each institution may rely upon the intentions and actions of the other institutions. This MOU shall have an initial term of five (5) years from the Effective Date, and the parties shall meet and review annually the status, assessments and any changes to support the educational opportunities set forth herein and as agreed to by the institutions.
- B. This MOU may be terminated by Stockton, Camden County College or Camden's Promise Charter School by written notice to the other institutions if:
 - 1. There shall have been a material breach of any of the agreements set forth in this MOU on the part of any institution, which breach (if susceptible to cure) is not cured within one hundred twenty (120) days following written notice to the institution committing the breach, or;
 - 2. An institution shall cease to maintain its accreditation or licensure, or;
 - 3. An institution or any of its employees or agents shall engage in any conduct that could reasonably be expected to adversely affect the reputation of the institution seeking termination.
- C. After the initial five (5) year term, any institution may terminate this MOU for any reason or no reason upon one year's written notice to the other institutions.
- D. In the event that this MOU is terminated, it is understood and agreed that the termination will not apply to those students already accepted to Stockton and Camden Academy under the terms of this MOU.

Compliance with Applicable Laws

- A. Each institution agrees to abide by the Family Educational Rights and Privacy Act ("FERPA") and any other applicable federal and state laws/regulations addressing student privacy. Any student data proposed to be shared (whether before or after the execution of this MOU) will be shared only in compliance with FERPA or any other applicable federal and state laws.
- B. Stockton, Camden County College and Camden's Promise Charter School, in their programs and services, shall adhere to New Jersey's non-discrimination policy for Affirmative

Action and Equal Employment Opportunity. In accordance with that policy, all institutions participating in this MOU will not discriminate based upon race; creed; color; national origin; ancestry; age; sex; marital status; familial status; affectional or sexual orientation; atypical heredity, cellular, or blood trait; genetic information; liability for training and service in the Armed Forces of the United States; or disability.

C. This MOU will be governed by, and construed under, the laws of the State of New Jersey without regard to conflicts-of-laws principles.

D. This MOU may be executed in one or more counterparts, each of which will be deemed an original of this MOU and all of which will be deemed to constitute the same letter. To the extent permitted by law, a signature delivered via facsimile or email will be considered as an original for the purposes of acknowledging and agreeing to the terms of this MOU.
