Fall 2020

- Met with Faculty Senate President, identified a need for a student survey in the wake of COVID-19.
- Partnered with Office for Student Affairs to strategize for the development and deployment of a student survey.
- Met with student senate representative to get information for the survey
- Had several meetings via zoom with Vice President for Student Affairs and key members from his staff to discuss the survey instrument's purpose and relevant questions.
- I chaired a subcommittee that fine tuned the survey based on input from committee members. (special thanks to Eric Jeitner and Suya Yin)
- Met Roberto Castille to set up Qualtrics as the platform to deploy the survey
- Email communication with Valerie Hayes on securing funds for the committee 300.00 (Still in Process)
- Communicated with Dan Nugent, Cynthis Crager to develop a strategy for securing and oversight for spending a 300.00 donation for the Committee to use if needed. (Still in progress).
- In December, the survey was revoked, unaware UROC deployed a similar survey

Spring 2021

- Met with Dr. Rachel Kirzner to discuss research opportunities as a follow up to students and faculty working together on research projects as per Dr. Shah's request.
- Recently met with the Provost and Daniel Nugent to see if our Committee could be of assistance for revising the Honorary Degree policy.
