2021-2022 Monthly Meeting

2021-2022 Committee Activities (selected major topics):

- 1. CTLD and ITS shared updates on Blackboard Ally and discussed Blackboard Ultra use in the Fall semester.**
 - An updated version of Blackboard, which was called Blackboard Ultra-navigation, with a lot of additional benefits went live in summer 2021 and has been available for faculty to use since then.

- The major change would be that of moving from a Blackboard hosted platform to a SAS platform, which had a lot of backend benefits to it. Also, it was more cost effective.
- This would also allow enabling blackboard ally, which made the uploaded content as accessible as possible, being compliant to the ADA.
- The new system ensured automatic enrollment to the corresponding blackboard course, as soon as students register for it. Also, a student would automatically be removed from blackboard once they dropped a class.
- At the beginning of the fall semester all courses are in “instructor choice” mode. If an instructor wants to use Ultra they can follow these steps to set their course to ultra (<https://stockton.edu/blackboard-tutorial/instructor-tutorials-ultra/ultra-switch.html>). If they wish to use original/classic, they don’t have to make any changes and can continue to use the system as they normally would.
- Currently, we only had about 40 courses that were running in ultra view.

2. LMS project exploration (Please see attachment for detailed survey report)

- ITMS committee invited **Dr. Emari DiGiorgio** and **Dr. Heather McGovern** to give demonstration of the Canvas use in instructional settings.
- ITMS committee invited **Dr. Kahanov** to discuss about coordinating the LMS with ADA compliance requirements and enhancing pedagogy and inclusion of quality matters criteria/monitoring.
- ITMS committee in collaboration with CTLD and ITS hold the Blackboard and Canvas Product Demonstration session on Oct 22nd, 2021
- ITMS committee distributed the faculty survey on alternative LMS exploration from Oct 23rd, 2021 to Nov 30th, 2021
- ITMS committee invited **Dr. Christine Tartaro** to present the association analysis results
- ITMS committee members **Dr. Melanie Schroer** and **Dr. Lisa Youngblood** conducted qualitative analysis for the survey and they presented the results

3. (Ongoing project) The committee will review and provide recommendation on the need for qualitative software
