- 2. Invited the Registrar's Team (AmyBeth Glass, Kate Spalding, Bernadette Morris) to give us a presentation on the new Degree Works upgrades and ADA Compliance enhancements.
- 3. Discussed about the qualitative software
 - As part of Dr. Rachel Kirzner role as AY22 CTLD faculty fellow for Technology and Pedagogy, surveyed faculty on technology use, preferences, and requests.
 - o Regarding recommendations, there was a range of usage, interest, and requests for training on a wide variety of tech tools.
 - We plan to review and provide recommendation on the need for qualitative software next semester.
- 4. Proceeded with the investigation of alternative Learning Management System (LMS), conducted a comprehensive survey among the faculty, and produced a final report summarizing our finding (see **Final Report** in the appendix)
 - The ITMS subcommittee hosted a panel discussion to learn about the major differences between Blackboard/Ultra and Canvas, including the challenges and advantages of transitioning from one to the other on March 21st, 2023.
 - The ITMS subcommittee developed an infographic summarizing information collected by the ITMS subcommittee over the past two years.
 - \circ The ITMS subcommittee conducted a faculty-wide vote from April 27th to May 6th, 2023 to selected preferred LMS.
 - The ITMS subcommittee summarized a report to explain the vote results and ITMS subcommittee recommendations.
