Documentation for Sponsor's Affidavit of Support

Applicants must accurately present proof of available funds to cover the cost of their first year of study and living. All documents must be translated in English and all currencies presented in US dollars.

1. Who can be a sponsor?

- a. A student can sponsor him/herself completely or partially, if proof of enough personal funds are provided
- b. A family member, a friend, or an organization who is willing and able to support your study in the U.S.
- Scholarship: Official, original scholarship letter from the institution awarding the scholarship. The award letter must cite the name of the applicant, the amount of money (in U.S. dollars) available for each year of study, the duration of the award (including beginning and ending dates), and the terms of the award.
- Government/Employer: Official, original letter indicating the amount of support and containing the same information for "Scholarship" as described above.
- 2. **ACCEPTABLE** financial support documentation:
 - a. Applicant's personal bank statements
 - b. Sponsor's bank statements
 - c. Sponsors' proof of personal income (Pay stub, employment letter or tax return form)
- 3. **UNACCEPTABLE** documentation (examples):
 - a. Funds from another foreign student or research scholar already in the U.S.
 - b. Funds from anticipated employment as an international student;
 - c. Documents that do not state the recent and accurate balance in the account(s)
 - d. Documents of Real estate or any other fixed assets.
- 4. Financial support documents **must** be submitted with the **Sponsor's Affidavit of Support**. All financial documentation must reflect resources within **six (6) months**, of the submission of the Application for I-20.
