NSF BIO Directorate Eliminates Deadlines for Most Programs

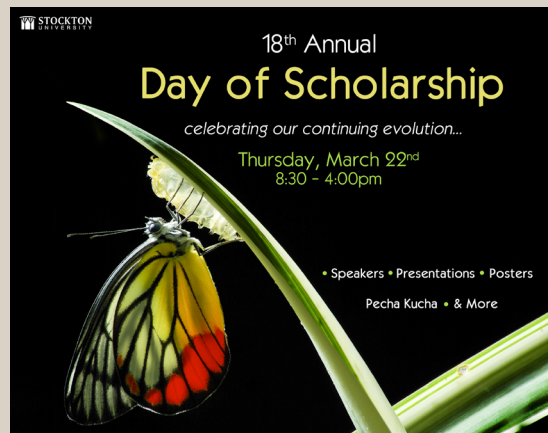
The majority of programs within the National Science Foundation's Directorate for Biological Sciences (NSF BIO) will do away with annual deadlines next year, and accept proposals at any time. Starting in calendar year 2018, core programs in the Division of Environmental Biology (DEB), the Division of Integrative Organismal Systems (IOS), the Division of Molecular and Cellular Biosciences (MCB), and the Research Resources Cluster of the Division of Biological Infrastructure (DBI) will move to a "no-deadline" model. Any upcoming deadlines in calendar year 2017, such as those for the [DBI](#) and [MCB](#) programs, are still active.

While this change affects most BIO programs, some grants will still have set deadlines. IOS will support projects for genomic tool development through the Enabling Discovery through Genomic Tools program. DEB will support integrative research in the [Ecology and Evolution of Infectious Diseases](#) (EEID) program and the [Dimensions of Biodiversity](#) program. DBI will support the [Postdoctoral Fellowship in Biology](#) program. The [Macrosystems Biology and Early NEON Science](#) program will remain under deadlines. Broader programs like CAREER, MRI, or REU are not affected by this change.

NSF says that prior experience with eliminating deadlines in the Geosciences Directorate and in the BIO Plant Genome Research Program have paid heavy dividends. Their results saw reduced burden on institutions, improved morale from existing stakeholders, and a decrease in the number of proposals submitted (lessening strain on NSF staff), which corresponded with an increase in proposal quality.

Funding for Colleges and Universities to Help Communities Meet Food Needs

The National Institute of Food and Agriculture's (NIFA) Community Food Projects (CFP) grants program offers an opportunity for colleges and universities to help meet the food needs of low-income individuals in their surrounding communities. Eligibility is limited to public food program service providers, tribal organizations, or private nonprofit entities, but applicants are encouraged to enter into partnerships with other organizations, including academic institutions. CFP grants can be used to support food initiatives in a number of areas including: food distribution, community outreach, improving food access, increasing community food self-reliance, developing comprehensive local food access systems, and more.
