Call to Order: President Dambroski called the meeting to order at 4:30pm.

President Dambroski welcomes everyone to the full senate meeting.

Jess Cathcart takes the roll.

President Dambroski welcomed, Senators Damien and Camillo, who are taking their place on the Finance and Academic committees respectively.

President Dambroski moves to approve the minutes, Senator Syeda seconds.

The minutes are approves with a vote of, 25-0-1, with President Dambroski abstaining.

#### **President's Report**

President Dambroski hopes the semester is off to great start. She wanted to give a few updates from last semester, in regards to Stockton exhibition committee she gave an introduction to the exhibition committee and its purpose. Research has concluded thus far, at the time the university was founded, the board of higher education (which no longer exists) originally asked to be named South Jersey state college. This request was declined, as it was too geographic. After that, the board of trustees picked Richard Stockton. There wasn't much research behind Richard Stockton, and there was a false biography that was popular at the time about him, and they went with it. President Dambroski said the situation is really stinky now as we realize the type of person he was. President Dambroski was hoping to get together soon to make a plan about the future of the bust. The committee has been looking into types of statues to ironically reflect the situation. New signs in the library have been added, but the bust is still removed. The administration has sent list of actions on resolution passed last semester. President Dambroski explained the letter is lengthy, and will go over it with senators. She mentioned that students can expect a report from student senate on the administration's actions on the resolution. She encouraged everyone to get involved with unite against hate day on February 6th, hoping for an event of unity.

#### Vice President's Report

President Dambroski yields the floor to Vice President Hanvey

VP Hanvey met with Deana Button, policy chair, and gave a brief update on the resolution passed FA17-02, resolution addressed retaking a course policy. She explained that the resolution failed in the academic policy committee on faculty senate. Therefore, it has not been

sent to the administration. She is currently negotiating with faculty senate on limitations on the policy. She encouraged students to check social media for the resolution. She has also been working on a really cool event: Parking Ticket Forgiveness Day. This allows students to be reimbursed one parking ticket if they donate 2 nonperishable items to the Stockton Food program. VP Hanvey thanked the Community Engagement Center, Craig and Jeff for help. She welcomed representatives of the Teal Blue Ribbon project and honored them for their dedication to sexual assault awareness and holding Q&A. She congratulated them for them being a new club and their hard work. VP Hanvey gave updates on Unite Against Hate.

### Finance

President Dambroski yields the floor to Chairperson Greene to give the Finance report.

Chairperson Greene reported that Finance has been busy, with a handful of supplementals. He first reported several that were \$1500 and under:

Stockton Gaming Club, \$313.16, for their Chess tournament.

Coalition of Women's Rights, \$480.20, for their Sex Toy bingo.

EoF Students of New Jersey; HOPE's Black Solidarity Conference at Yale

University, \$1093.65.

Circle K District Convention to Freehold, \$1480.

African Student Organization, for multicultural show, \$3,000.

Chairperson Green invited a student representative to speak for the club.

The Representative explained that the event will uplift students of different cultures and fashion, bring a wholesome event that will educate people as they learn about different cultures and fashion.

Chairperson Greene moves to pass supplemental request in the amount of \$3000.

President Dambroski addresses the motion, Senator Katy seconds.

24-0-2, motion passes.

Supplemental request for Asian Student Alliance (ASA) for conference in the amount of \$3300. Chairperson Green invited a student representative to speak.

The representative explained that the event is a workshop for Asian Americans to learn more about the Asian culture and that it was a networking event. He explained how he wants to be able to bring workshops back to Stockton.

They also offered screening for a week, and will be holding events throughout campus through February. Senator Janeice asked about the particular events.

The Representative explained that they will be having 2 national speakers, holding deep screening trainings with social work club, and hosting 2 mental health first aid trainings. The representative had a thank you card that was presented to the senate for their support last semester.

Chairperson Greene moves to approve a supplemental in the amount of \$6,911.06.

President Dambroski addressed the supplemental, it was seconded by Senator Monica.

Senator Coburn thought it would make a large impact on campus throughout the month, well worth it.

She thanked Senator Franklin attending meeting for sexual assault awareness, and urged the public and senators to attend events. She also met with a student in regards to weekend activity, where she stated that she would look into creating a bike and trail map to show students what's on campus. Chairperson Ritter also stated she was looking into ideas for activities at Lake Fred, and talked to Jim Loprer. She also spoke about the sustainable cups and reported that they have ran out, and a new order was placed. The Governmental Affairs Committee hosted a "Hi From The Other Side event" on Monday February 12 in the campus center coffee house at 4pm. The event's turnout was underwhelming, but we are learning from our mistakes and we hope to host a similar event in the future with better results. We are also hoping to host "Hot Topic" political debates throughout the semester. We are planning to have students Anthony Farfalla and Thomas Urbanik debate the 2nd amendment and gun control policy.

We have set a date for a lobbying trip to the state capital as Thursday April 5. We plan to leave early in the morning and arrive in Trenton at 9 am and leave by noon to be back at 1:30 p.m. We are also looking to host a primary town-hall for the congressional district two race coming in 2018.

The Governmental Affairs Committee has undergone constitutional revisions and is bringing this consent agenda to the floor for passage:

*The reason* for all of these constitutional changes are to clean up the constitution a bit, as well as make it more relevant to our actual functioning.

Article II "Organization"

*This change reflects* the Senate's practice over the past few years of appointing a "Chief of Staff" to do the work of maintaining meeting minutes.

Section 1, part D reads: The Student Senate may hire an Office Manager.

**New-** Section 1, part D reads: The Student Senate may appoint one or two Chiefs of Staff who assume the main responsibility of maintaining meeting minutes.

Article III "Meetings"

*This change accurately reflects* how the Senate typically goes about meetings. It is important the Finance committee goes first to get supplementals voted on. Another CoS correction is also made.

Section 1, part D reads: Presiding order: President, Vice President, Chair of Academic Affairs, Chair of Student Affairs, Chair of Public Relations, Chair of Government Affairs, Chair of Finance.

**New-** Section 1, part D reads: Presiding order: President, Vice President, Chair of Finance, Chair of Student Affairs, Chair of Academic Affairs, Chair of Government Affairs, Chair of Public Relations.

Section 3, part C reads: The Executive Cabinet will make changes seen fit and provide the edited minutes to the office manager (or the Vice President in the absence of an office manager) for adjustment.

**New-** Section 3, part C reads: The Executive Cabinet will make changes seen fit and provide the edited minutes to the chief of staff (or the Vice President in the absence of a chief of staff) for adjustment.

Article IV "Duties, Powers, and Responsibilities"

*These changes reflect* the reality that these responsibilities or rules do not accurately describe our operational structure. The Class Councils no longer exist. There is extra wording describing specific programs that is unneeded.

Section 4 (President) part P reads: May not serve as the student member of Stockton University Board of Trustees or Vice President / President of the Class Councils.

**New-** Section 4 (President) part P reads: May not serve as the student member of Stockton University Board of Trustees.

Section 4 (President) part T reads: Manage all special projects as necessary, including such as Students Helping Student, The Food Assistance Program, and the emergent needs.

**New-** Section 4(President) part T reads: Manage all special projects as necessary, including outreach.

Section 5 Part A: Assume the powers and duties of the President in his/her absence.

**New-** Section 5 Part A: Assume the powers and duties in the case of the President the president's absence.

Section 5 (Vice President) part K reads: Collect and assemble committee meeting minutes from the Executive Cabinet for the full senate meetings in the absence of an office manager.

**New-** Section 5 (Vice President) part K reads: Collect and assemble committee meeting minutes from the Executive Cabinet for the full senate meetings in the absence of the chief of staff.

Section 5 (Vice President) part N reads: May not serve as the Student Member of the Stockton University Board of Trustees. or Vice President / President of the Class Councils.

**New-** Section 5 (Vice President) part N reads: May not serve as the Student Member of the Stockton University Board of Trustees.

**Delete:** Section 6 (Committee Chairperson) part F i. reads: The Academic Affairs Committee shall oversee an annual review of the Student Senate Constitution and Statutes of the Student Senate and recommend modifications where necessary.

**Delete** Section 6 (Committee Chairperson) part H iv. reads: Compile the application and the election for the students' interest in being a member of New Jersey United Students Board.

**Add:** Section 6 (Committee Chairperson) part H viii reads: The Governmental Affairs Committee shall oversee an annual review of the Student Senate Constitution and Statutes of the Student Senate and recommend modifications where necessary.

Section 7: Committees Part B (Finance Committee) reads: The finance committee liaison will schedule his/her organizations in five minute intervals at a specific location. He or she will notify the clubs of their specific meeting time at least one week before the actual date.

**New-** Section 7: Committees Part B (Finance Committee) reads: The finance committee liaison will schedule their organizations in five minute intervals at a specific location. They will notify the clubs of their specific meeting time at least one week before the actual date.

# Article V "Elections"

Section III: President Part C reads: At the last committee meeting before the Spring election, the whole Senate votes to nominate the candidates for President. No Senator may nominate his or herself, and may not be nominated for both President and Vice President.

**New-** Section III: President Part C Reads: Before the Spring election, the whole Senate votes to nominate the candidates for President. No Senator may nominate his or herself, and may not be nominated for both President and Vice President.

Article VI "Vacancy"

Section I Part E: An alternate shall fill out the term of his/her predecessor.

**New-** Section I Part E: An alternate shall fill out the term of their predecessor.

We presented the changes to the governing body last Tuesday.
