ARTICULATION AGREEMENT

BETWEEN

THE RICHARD STOCKTON COLLEGE OF NEW JERSEY 101 VERA KING FARRIS DRIVE GALLOWAY, NJ 08205

AND

ATLANTIC CAPE COMMUNITY COLLEGE 5100 BLACK HORSE PIKE MAYS LANDING, NEW JERSEY 08330

IN THE AREA OF BIOMEDICAL SCIENCE

THIS ARTICULATION AGREEMENT ("Agreement), effective as of the date of the last signatory below, is made by and between The Richard Stockton College (RSC) of New Jersey, 101 Vera King Farris Drive, Galloway, NJ 08205 and Atlantic Cape Community College (ACCC), 5100 Black Horse Pike, Mays Landing, New Jersey 08330. The Richard Stockton College of New Jersey and Atlantic Cape Community College agree to confirm in writing the terms and conditions of mutual and individual responsibilities related to the offering of this joint program. As set out in this Articulation Agreement.

RECITALS

WHEREAS, Atlantic Cape Community College and The Richard Stockton College of New Jersey seek to improve the quality of biomedical science programs for students; and

WHEREAS, Atlantic Cape Community College and The Richard Stockton College of New Jersey seek to improve and facilitate transfer of biomedical science students; and

WHEREAS, Atlantic Cape Community College and The Richard Stockton College of New Jersey seek to increase opportunities for biomedical science students; therefore

The purpose of this Agreement is to establish cooperative academic relations between The Richard Stockton College of New Jersey and Atlantic Cape Community College so that students successfully completing the A.S. degree in biomedical science can seamlessly transfer their course and credits toward the requirements of related B.A. and B.S. degrees from The Richard Stockton College of New Jersey as well as having these courses accepted upon application to professional schools in the biomedical sciences.

Following is a list of those B.A. and B.S. degrees considered related with respect to this articulation agreement:

- B.A. in Biology Health Professions Concentration
- B.S. in Biology Health Professions Concentration
- B.A. in Biology Pre-Physical Therapy Concentration
- B.S. in Biology Pre-Physical Therapy Concentration
- I. According to this articulation agreement:

The Richard Stockton College of New Jersey will accept as prerequisites to specific B.A. and B.S. degree programs certain courses as itemized in Paragarph I. B below (Appendix A) that also meet the characteristics as specified in the courses syllabi at The Richard Stockton College of New Jersey.

- B. Science and Mathematics courses See Appendix A
- C. Students must apply to and be accepted to ACCC, and designate Biomedical Science as their major.
- D. Students must be admitted to RSC via the Stockton-ACCC Dual Degree Program.
- E. RSC will provide appropriate precepting to ACCC students majoring in Biomedical Science via its Office of Academic Advising and the College's Health Professions Advisor.
- F. Students must have earned the Associate of Science degree in Biomedical Science from ACCC, and provide an official ACCC transcript so indicating.
- G. Students must complete all Science and Mathematics courses with a GPA of 3.0 or higher with all Science and Mathematics having a grade of "C" or above.
- II. Atlantic Cape Community College will provide evidence of meeting the state and national standards that are met by The Richard Stockton College of New Jersey.

III. Term of Agreement

This Agreement shall commence as of the date of the last signatory below. This Agreement shall renew automatically each year for not more than three (3) years from the date of this contract, upon annual review, unless terminated upon one year's prior written notice by either party to the other. If terminated, those students already accepted in the Program will be allowed to complete the Program both at The Richard Stockton College of New Jersey and Atlantic Cape Community College if all academic requirements specified under this Agreement have been met. No further admission shall be made under this Program after such notice is given.

IV. General Provisions

- A. There shall be no discrimination against any employee engaged in the work required to produce the services and programs covered by this Agreement, or against any applicant for such employment because of age, race, creed, color, national origin, sex, ancestry, marital status, civil union status, domestic partnership status, flectional or sexual orientation, gender identity or expression, atypical hereditary, cellular or blood trait, genetic information, liability for service in the Armed Forces of the United States, nor handicap. This provision shall include, but not be limited to the following: employment, upgrading, demotion, transfer, recruitment or recruitment advertising; layoff or termination, rates of pay or other forms of compensation; and selection for training, including apprenticeship. The parties of this Agreement do hereby agree that the provision of N.J.S.A. 10:2-1 through 10:2-4, dealing with discrimination in employment on public agreements, and the rules and regulations promulgated pursuant thereunto, as the same may be amended or modified,
- B. Atlantic Cape Community College shall have in place a sexual harassment policy. Students shall have been provided with a copy of the policy and procedures for reporting incidents of any kind of bullying or sexual harassment as defined by the Equal Employment Opportunity Guidelines Commission and/or the State of New Jersey.
- C. Under this Agreement, both Atlantic Cape Community College and The Richard Stockton College of New Jersey shall continue to be autonomous and shall be governed independently by their respective governing bodies and administrations except insofar as this Agreement specifically states to the contrary.
- D. It is understood and agreed that the parties to this Agreement may revise or modify this Agreement by written amendment when both parties agree to such amendment.
- E. This Agreement shall be governed and construed and the rights and obligations of the parties hereto shall be determined in accordance with the laws of the State of New Jersey in the courts of the State of New Jersey.

V. Indemnification

- A. The Richard Stockton College is prohibited from providing any indemnification under the provisions of N.J.S.A. 18A:64-82. The College participates in the State of New Jersey's self-insured risk retention program. The College does not carry separate public liability insurance but manages risks through the State's Program and is accorded certain statutory immunities under the terms and provisions of the New Jersey Tort Claims Act. (N.J.S.A. 59:1-1 et seq., New Jersey Contractual Liability Act N.J.S.A. 59:13-1 et seq. and the New Jersey Charitable Immunity Act, N.J.S.A. 2A:53A-7 et seq.
- B. Atlantic Cape Community College shall indemnify and hold harmless The Richard Stockton College of New Jersey, its agents, and employees, from any and all liability, and expense (including reasonable attorneys' fees) arising from the negligence of Atlantic Cape Community College, its students, agents and employees, in conjunction with or arising out of the activity which is the subject of this Agreement.

VI. Warranties

- A. The Richard Stockton College of New Jersey and Atlantic Cape Community College do hereby warrant and represent that they are qualified by training and experience to perform the required services and programs in the manner and on the terms and conditions set forth herein. The Richard Stockton College of New Jersey and Atlantic Cape Community College further warrant and represent that this Agreement has not been solicited or secured, directly or indirectly, in a manner contrary to the laws of the State of New Jersey and that said laws have not been violated and shall not be violated as they relate to the procurement or performance of this Agreement by any conduct, including the paying or giving of any fee, commission, compensation, gift, gratuity, or consideration of any kind, directly or indirectly to any State employee, officer or official.
- B. The Richard Stockton College of New Jersey and Atlantic Cape Community College administrators shall review the progress and policies of the Agreement at least once a year.

VII. Entire Agreement

Both The Richard Stockton College of New Jersey and Atlantic Cape Community College acknowledge that this Agreement represents the entire agreement between the parties. All negotiations, oral agreements, and understandings are merged herein, and any change in the terms herein must be made in writing and signed by both parties.

VIII. Notice
